2020 Post-Election Analysis

President-Elect Joe Biden (D) vs. President Donald Trump (R)

The results of the Presidential election will have a tremendous effect on the behavioral health community, specifically licensed professional counselors. The President's stance on mental health will determine the urgency and the pace in which legislation is signed into law. Below is each candidate's stance as well as some of their health care priorities.

President Trump on Mental Health:



"At a time when many Americans are experiencing increased stress, anxiety, and personal loss, we must also ensure that our country can meet the mental health needs of those struggling in this crisis."

- President Trump signed an Executive Order to address the negative impact of prolonged shutdowns on mental and behavioral health and increase suicide prevention efforts.
- The President is establishing a cabinet-level working group to assess the mental health needs of the most vulnerable, including the elderly, minorities, children, veterans, and people with disabilities.
- The President signed legislation which allocated approximately \$425 million in emergency funds to address mental and substance use disorders.

President-Elect Biden on Mental Health:



"As a society, we need to work together to eliminate the stigma felt by those who are suffering and struggling with their mental health. We must ensure that everyone has access to affordable quality health care and that mental health services are covered."

- "As President, I will ensure enforcement of mental health parity laws and expand funding for mental health services."
- "I will accelerate the deployment of telehealth for mental health and specialty care for rural communities."
- "I will make an unprecedented investment in school mental health professionals in order to double the number of psychologists, guidance counselors, nurses, social workers, and other health professionals employed in our schools."


Key Senate Races

- Many of the 35 seats up for grabs this year were uncompetitive; so control of the Senate depended on a handful of hard-fought races.
- Currently, Senate Republicans hold a three-seat majority and control the Senate. That may change with the results of key Senate races.
- If Democrats take control of the U.S. Senate, it could lead to laws that shake up key sectors such as health care, finance, and energy.
- Republicans currently hold 53 seats in the Senate, so Democrats need to gain four seats to take control of the chamber — or just three if Biden wins the presidential election, because a Democratic vice president, Kamala Harris, would cast tie-breaking votes.
- So which Senate races were worth tracking? We took a look at key Senate races which had the most impact on who controls the Senate moving into the 117th Congress.

KEY HOUSE RACES

- Democrats took control of the House of Representatives in the 2018 midterm election and are widely expected to remain in control of the House after this November’s election.
- Half of the key House races on our list, most likely to flip partisan control are GOP-held seats.
- Many share similarities with the kinds of demographically changing and increasingly suburban districts where Republicans saw slippage in 2018.
- Six of the 10 districts on this list are open seats, where the incumbent is not running for reelection and half of those are in Texas, which the Democratic Congressional Campaign Committee has called “ground zero”.
- However, in districts where the incumbent is a known brand, like in the case of Representative John Katko (R-NY-24), an original co-sponsor of H.R.945, the Mental Health Access Improvement Act of 2019, it may be an easy win.

Rep. Ben McAdams (D): Incumbent



- Burgess Owen, a former NFL player and Fox News commentator who won a four-way primary, is giving Democratic freshman Rep. Ben McAdams a competitive race.
- Owens isn't distancing himself much from the President, embracing his rhetoric about fighting socialism.
- Utah has been less friendly to Trump than other red states, and the 4th District has a history of electing moderate Democrats.

American Samoa

Lemanu Palepoi Mauga (Nonpartisan)



☑ Winner

Lt. Governor Mauga is proposing a broad spectrum of policy proposals that invest in culturally appropriate education and career readiness, including, stronger career pathways for K-12 students as well as, salary increases and appropriations for counselors and administrators in educational settings and counselor recruitment.

Nuanuaolefeagaiga Saoluaga T. Nua (Nonpartisan)



Nua's policy proposals center around a clean and energy independent American Samoa. Nua proposes promoting renewable energy sources such as solar, wind, hydro-electric, ocean and biomass. Nua's campaign platform does not specifically outline any plans regarding health care or mental health.

l'aulualo Fa'afetai Talia (Nonpartisan)



l'aulualo and Tapa'au are running their campaign around their healthcare policy which includes addressing substance use disorders (SUDs) through evidence based community care and building up the entire health care workforce, including appropriations for student loan forgiveness and an independent regulatory board.

Gaoteote Palaie Tofau (Nonpartisan)



Senator Tofau's policy proposals focus on building up the health care workforce, building a drug rehabilitation and treatment center, updating Medicaid implementation, provide greater health care resources to correctional center, and investments in telehealth.

**Gov. John Carney (D)
Incumbent**



☑ **Winner**

- Governor Carney helped introduce the *Beau Biden Gun Violence Prevention Act* to help directly confront the issue of mental health and gun access. The *Beau Biden Act* passed unanimously and was signed into law.

Julianne Murray (R)



- Murray plans is to declare opioid abuse a Public Health Emergency:
- Statewide Task Force on Opioid Drug Abuse
- Modify Prescriber Practices
- Community Health Education Initiatives
- Crack Down on the Spread of Illegal opioids in the state.

Indiana

**Gov. Eric Holcomb (R)
Incumbent**



☑ **Winner**

- Governor Holcomb has established *BeWellIndiana.org*, provides free mental health resources that have been vetted by experts.

Dr. Woody Myers (D)



- Dr. Myers is focusing on the health care disparities made apparent by COVID-19. Dr. Myers plans to increase access and affordability through investments in telehealth infrastructure, providing incentives to address provider shortages particularly in rural areas.

Missouri

**Gov. Mike Parson (R)
Incumbent**



☑ **Winner**

- Governor Mike Parson is running for re-election prioritizing stronger communities through investments in public safety and health care to offset the damage of COVID-19.

Auditor Nicole Galloway (D)



- As Governor, Auditor Galloway pledges to create an Office Of Health Policy. The Office of Health Policy will allow reimbursement for in-home care, including acute care; to expand community programs combatting the opioid crisis; and to expand Medicaid coverage to include clinics in every county, telehealth reimbursement support, and expanding access to mental health care.

Montana

Lt. Governor Mike Cooney (D)



- Lt. Governor Cooney proposes focusing on public health policy in order to increase access to behavioral and rural health care.

Congressman Greg Gianforte (R)



✓ **Winner**

- Congressman Gianforte has consistently stressed the need to ensure quality health care for veterans who may be suffering from Post-Traumatic Stress Disorder (PTSD). Congressman Gianforte aims to do this through increased resources for the VA system, improved access to community care, and the expansion of telemedicine.

New Hampshire

Gov. Chris Sununu (R): Incumbent



✓ **Winner**

- In 2019, the New Hampshire Department of Health and Human Services (DHHS) released the “10-Year Mental Health Plan.” The Plan will provide access to the full continuum of care, including community education and engagement; prevention and early intervention services; outpatient, inpatient and crisis supports and services; child-focused strategies; the integration of mental health and primary health care; and intensified efforts to address suicide prevention

State Senator Dan Feltes (D)



- Sen. Feltes led the charge for affordable health care, paid family and medical leave insurance, clean energy, and common-sense gun safety. Sen. Feltes proposes to protect Medicaid expansion, continue combating the opioid crisis, aid senior citizens in enhancing access to healthcare, and further implement the first-ever comprehensive children’s system of mental health care in New Hampshire, including a statewide mobile crisis and intervention team for children.

North Carolina

Gov. Roy Cooper (D): Incumbent



✓ **Winner**

- Governor Cooper signed into law Senate Bill 476 – School Based Mental Health. Governor Cooper also oversaw the creation of the *North Carolina Task Force for Racial Equity in Criminal Justice* to address racial inequities in North Carolina’s criminal justice system.

Lt. Gov. Dan Forest (R)



- Lt. Governor Forest proposes greater healthcare access by incentivizing doctors to practice in rural communities. Additionally, Lt. Governor Forest has promised to work with the General Assembly and the State Treasurer to ensure price transparency for prescription drugs and vital health services.

North Dakota

**Gov. Doug Burgum (R):
Incumbent**



☑ **Winner**

- Governor Burgum received support for a Presidential Disaster Declaration Request to focus on the health and welfare of those in North Dakota during the COVID-19 pandemic, including behavioral health.

Dr. Shelley Lenz (D)



- Dr. Lenz proposed working with the state legislature to increase access to holistic preventative health care including nutrition, mental health, dentistry, vision, physical rehabilitation, senior and geriatric care, especially for rural communities.

2020 Gubernatorial Races

Puerto Rico

Pedro Pierluisi (PNP) (D)



☑ **Winner**

Pierluisi is a candidate from the incumbent "New Progressive Party" (PNP) that seeks statehood. Pierluisi is predominately focused on economic recovery from COVID-19 and recent natural disasters in Puerto Rico focusing on critical areas for investment including health care, education, infrastructure, and workforce support.

Carlos Delgado Altieri (PPD)



Mayor Delgado is a member of the governing body of the "Popular Democratic Party" (PPD). In 2017, Mayor Delgado's policy proposals focused primarily on economic development, social inequality, and public security. His campaign platform does not specifically outline any plans regarding health care or mental health.

Senator Juan Dalmau (PIP)



Dalmau proposes a new relationship between Puerto Rico and the United States as a non-colonial territory. Dalmau's campaign platform does not specifically outline any plans regarding health care or mental health.

Alexandra Lúgaro



Among Lúgaro's policy proposals are an increase in the minimum wage, violence prevention in schools, eliminating wage inequality, and workforce development.

Utah

**Lt. Governor
Spencer Cox (R)**



☑ **Winner**

- To combat the rising suicide rate, Governor Herbert established the Teen Suicide Prevention Task Force in January 2018. The task force has successfully advocated for 11 enacted bills expanding mental health and suicide prevention resources and programs throughout Utah.

Chris Peterson (D)



- Peterson aims to make healthcare more accessible and affordable by streamlining the healthcare system. Peterson has also expressed an interest in bolstering mental health resources in order to curb rising cases of mental illness and suicide.

Vermont

**Gov. Phil Scott (R):
Incumbent**



☑ **Winner**

- In 2017, Governor Scott signed into law an Act that established the Mental Health Crisis Response Commission. The Commission was created to review and improve law enforcement interactions with persons assumed to have a mental health crisis through exhibiting certain behaviors.

**Lt. Gov. David
Zuckerman (D)**



- Lt. Gov. Zuckerman has pledged to ensure Medicare and Medicaid remain fully funded. Lt. Gov. Zuckerman also pledges to support the Veterans Medical Center in White River Junction, to support efforts to combat substance use disorders (SUDs), and to support mental health efforts in the midst of the COVID-19 pandemic.

- Governor Jay Inslee proposes focusing on strengthening the state psychiatric hospitals and redesigning the community-based behavioral health care system; integrating physical and behavioral health services for Washington Apple Health (Medicaid) clients; and fighting the opioid public health crisis.

Loren Culp (R)



- Loren Culp has prioritized addressing the COVID-19 pandemic, supporting unions, reducing government regulation and taxes, conserving natural resources, and education. Culp's campaign platform does not specifically outline any plans regarding health care or mental health.

2020 Gubernatorial Races

West Virginia

- Governor Justice has worked to promote a culture of health in rural West Virginia through the implementation of the “Creating a Culture of Health in Rural West Virginia” strategy report. Through implementation of this report, Governor Justice encourages investments; tracking; and creating programs to address substance use disorders (SUDs), addiction, and chronic mental health disorders.

Commissioner
Ben Salango (D)**



- Commissioner Salango has pledged to fight the escalating cost of health care in order to make health care affordable and accessible. Salango pledges to prioritize telehealth technology in order to give rural communities better access to health care.

Medicare

- This election cycle, candidates on both sides of the aisle have been vocal about the need to expand health care coverage to more Americans.
- The conversations surrounding Medicare has included a restructuring of the 55-year-old program that provides health care to most Americans over age 65 and those with disabilities, and “Medicare for All.”
- This year H.R.945, the Mental Health Access Improvement Act, was voted out of committee and is set to be voted on by the full House, then onto the Senate. Since we are entering a lame duck session, the bill will likely need to be re-introduced after the election, which would allow new members of both the House and Senate to review the legislation and potentially become a bill co-sponsor.

Education Funding

- The House has passed legislation upwards of \$436 billion for state and local relief; some of which states would likely use for education. There are policy and funding disagreements amongst the White House, House Democrats, and Senate Republicans.
- If relief funding is approved before the election, many state education budget cuts could be prevented.
- If a relief package isn’t approved soon, some education systems will have to make budget cuts which could possibly effect the establishment and retention of school counseling programs.

The Supreme Court

- If Supreme Court justices reverse rulings that aid in administering behavioral health services to Americans in need, those rulings could adversely impact the counseling profession.
- President Trump has decided to nominate Judge Amy Coney Barrett, who has since been confirmed to the Supreme Court, to replace Justice Ruth Bader Ginsburg.
- Adding Judge Barrett solidifies a 6-3 Conservative-Majority on the Supreme Court bench.
- Judge Barrett's conservative views on LGBTQ issues and the Affordable Care Act potentially places health care in jeopardy and could impact decisions and future rulings regarding mental health care in this country.
- On November 10, 2020, the Court is scheduled to hear oral arguments in the case of *California V. Texas* and *Texas V. California* regarding the constitutionality of the Affordable Care Act. The Court's decision could potentially disrupt the health care coverage of millions of Americans (during a pandemic), which would impact the counseling community.

117th Congress: Federal Post-Election Strategy

- The American Counseling Association (ACA) will continue its federal advocacy efforts within congressional offices as well as with other government entities regarding Medicare reimbursement for licensed professional counselors, additional funding for the establish and retention of school counseling programs, working with the veterans administration to provide more positons for professional counselors, and legislation to support college and career counselors.
- ACA has already started to prepare updated one pagers and white papers, which will be distributed within the first two weeks of the new legislative cycle to the offices of bill co-sponsors, as well as provide updated information to newly elected members of Congress.
- We will also re-introduce our Medicare legislation at the beginning of the New Year and communicate with lead sponsors in the House and Senate to collaborate on the bill.

Moving into the 117th Congress, ACA will also provide a 2021 strategy update – which will include updated information on our efforts surrounding the interstate compact as well as counseling and law enforcement. This is only a snapshot of how the 2020 elections may affect the counseling community.
